2. Did whitepanther773 kill my client, Mhadsher101, 2 times?

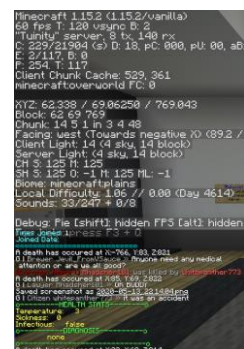
**IV. THE RESPONDENT VIOLATED THE CLAUSE IN QUESTION**

**1. OVERVIEW**

- C. On the May 13, at 10:14 pm EST, the second murder happened by whitepanther773. As you can see there is only 54 minutes in between the first and the second murder. So it is a well-planned attack on my client.

## **V. FIRST CAUSE OF ACTION**

1. Plaintiff realleges and incorporates the allegations set forth in each of the preceding paragraphs of this complaint.

2. DarkTrooper124 and whitepanther773 are in violation of the Murder Clause.

3. Respondents violation causes ongoing harm to the petitioner. (his armor was destroyed by the actions of DarkTrooper124 and whitepanther773. He felt unsafe for days and couldn't enjoy the server 100%.)

### **PRAYER FOR RELIEF**

**WHEREFORE**, Petitioner prays that the Court:

A. Declare that the Respondents be;

- Responsible for the actions of 2 murders by DarkTrooper124 and the 2 murders of whitepanther773. We want the maximum sentence of 200 dollars and 20 minutes in jail for each player. We ask that they will pay it in a maximum of 3 days after the decision, when they don't, the price will go up by 50 dollars a day.

- Responsible for the damage that they made. We want a compensation of 150 dollars for destroying the armor and 250 dollars fine for the first days that he couldn't play with fun, as he should be. It is 50 dollars for every day he couldn't play with fun. This is a must for my client.
