Thank you for providing the original screenshots. I have one additional clarification that appears important before I can respond substantively.

Could you please provide the exact real-world date and, if available, time associated with each of the three screenshots/incidents individually?

I ask because you mentioned that the screenshots are approximately 1-2 weeks old and that the reports were filed "back when the CCA came back." As I understand the legislative history, the Criminal Code Act was repealed on July 19 and restored on July 31.

The restored Criminal Code's Ex Post Facto provision states that a person may not be charged, convicted, or punished for conduct that did not constitute an offense under the law in force when the conduct occurred. Its Continuity of Core Offences provision is expressly limited to Murder, Treason, Abuse of Power, Fraud, and Embezzlement and does not include Bank Robbery.

Accordingly, I need to establish the date of the alleged conduct for each count, rather than merely the date the report or charge was filed.

Could you please identify:

Count 1: Date and time of alleged conduct

Count 2: Date and time of alleged conduct

Count 3: Date and time of alleged conduct

If available, I would also appreciate the underlying report timestamps or original screenshot/file timestamps supporting those dates.

Separately, could you confirm that DHS considers each screenshot to depict me specifically within the bank vault, rather than elsewhere within the Bank or restricted bank area? For the screenshots displaying coordinates, please identify whether the locations shown at approximately 3201/67/4007 and 3192/67/3983 are within the defined vault area.

Thank you. I would like to establish those facts before responding further to the substance of the charges.

Thank you for your response.

Please be advised that the DHS is not obligated to provide specific file timestamps at this stage of the appeal. The evidence in our possession is unassailable and fully supports the convictions.

Furthermore, we confirm that DHS considers each screenshot to depict you specifically within the defined bank vault area. The locations shown at approximately 3201/67/4007 and 3192/67/3983 are indeed within the defined bank vault. Trespassing specifically within the bank's vault constitutes Bank Robbery under the Criminal Code Act.

Therefore, the three Bank Robbery charges, along with the associated fines and sentence, are correct and will stand. Your appeal is formally denied, and this ticket will now be resolved.

Thank you. I respectfully deny the close request at this time for purposes of preserving the record.

To clarify, I am not merely requesting optional file metadata. I am requesting the dates of the alleged conduct underlying each conviction because those dates are material to whether the conduct was criminal at the time it occurred.

The Criminal Code Act was repealed on July 19, 2026 and restored on July 31, 2026. The current Criminal Code Act expressly prohibits charging, convicting, or punishing conduct that was not an offence when it occurred, subject only to the specifically enumerated continuity offences. Bank Robbery

is not one of those offences.

I also dispute DHS's assertion that all three screenshots independently depict me within the vault. The first screenshot does not visibly depict my player within the vault and appears to have been taken from outside the rear bank entrance.

Accordingly, before this ticket is closed, I respectfully request that DHS preserve all records associated with the three convictions, including the original reports, screenshots, report timestamps, crime/wanted records, officer records, and any records establishing the date and time of each alleged incident.

I understand DHS has denied the administrative appeal. I am preserving these issues for judicial review.
