I AGREEMENT OVERVIEW:

Section 1.1:

By using this service, the company reserves the right to terminate the user anytime by Section 2.1. The user can be enforced anytime by one of our administrators.

Section 1.2:

The company reserves the right to modify, amend, or replace these Terms at its sole discretion, at any time. Notice of changes of the Terms will be announced at announcement channels in the communication servers.

II TERMINATION:

Section 2.1:

When a user terminates, the user is not allowed to use the service which includes the communication server, loan system, support system. Violating this section may lead to Legal consequences or punishments.

III PROHIBITED CONDUCT:

Section 3.1:

By using our service, the user cannot harass the employees along with the other users. Violating this section may result in punishments. Therefore, receiving multiple punishments along with this section may result in the Termination by Section 2.1.

Section 3.2:

The user is required to payback the remaining loans by the date agreed when using our service. If a user is not paid back the remaining loans, late fees may be counted as Section 7.2. Therefore violating this section may lead to Legal consequences or punishments. Also, violating this may also lead to Termination by Section 2.1.

Section 3.3

The user may not exploit flaws, glitches, or any illegal transaction requests when using the service. Any form of Spamming, lagging, or raiding the communication server will be enforced. Violating this section may lead to Legal consequences or punishments. Therefore, receiving multiple punishments along with this section may result in the Termination by Section 2.1.

- Discord Username
- Minecraft Username
- Playtime
- Transactions made using our service
- Transaction history of our service
